



## Spelman College Greek Programming Report – Fall 2025

### The Stop Campus Hazing Act

The Stop Campus Hazing Act strengthens federal expectations for transparency and student safety by expanding the Jeanne Clery Campus Safety Act. The law requires colleges and universities to report hazing incidents publicly, publish a Campus Hazing Transparency Report, uphold a clear campus-wide hazing policy, and provide prevention education for all students. In keeping with its commitment to cultivating safe, supportive learning environments, Spelman College has aligned its established anti-hazing efforts with the Act's requirements.

### Spelman's Anti Hazing Policy

Spelman defines **Hazing** as any activity that is intentional, or unintentional due to reckless behavior, occurring on or off campus directed against a student that endangers or is likely to endanger the student's mental and/or physical health or safety regardless of a student's willingness to participate in such activity in connection with or as a condition or precondition of gaining acceptance, membership, office, or other status in a College organization. This activity is commonly associated with the student's membership, initiation, affiliation, pledging and/or association with an organization, but may include other activities. The definition includes, but is not limited to:

1. Screaming at an individual or group;
2. Belittling or humiliating participants;
3. Using derogatory, profane, or obscene language toward participants;
4. Requiring participants to engage in morally degrading or humiliating games (as perceived by the College community and/or participants);
5. Embarrassing activities;



6. Reputation-damaging activities;
7. Disheveling hair, tearing clothes; and
8. Using participants' cars, money, clothes, or other personal items.

### Office of Student Life & Engagement and Collaborative Greek Council

Within Spelman's Greek programming portfolio, the Office of Student Life and Engagement (OSLE) and the Collaborative Greek Council (CGC) prioritize anti-hazing education, prevention, and accountability. These efforts are embedded across all programs and initiatives to ensure each Greek organization upholds the College's standards for safety, integrity, and values-driven leadership.

*PJs With a Purpose* — A fun sisterhood event collecting supplies for a women's shelter.

*Steps & Sisterhood* — A two-hour campus walk promoting movement and peer connection.

*Breaths & Balance* — A mindfulness-centered wellness space for journaling and reflection.

**Total Unity Week Attendance:** Approximately 100 students.

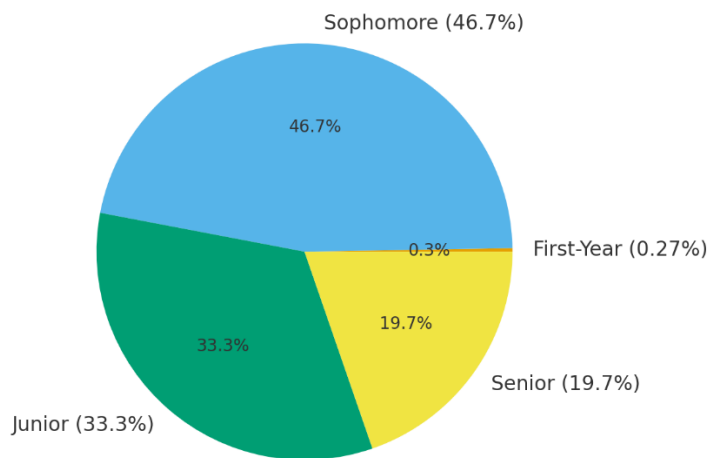
## 2. Greek Forum
